NOTICE TO AGENTS AND BROKERS OF NEW CENTURY INSURANCE COMPANY, IN LIQUIDATION

On September 3, 2025, the 126th Judicial District Court for Travis County, Texas (the “Court”), in Cause No. D-1-GN-25-07344 found New Century Insurance Company (“New Century”) to be insolvent and placed New Century into liquidation. The Court appointed the Texas Commissioner of Insurance as Liquidator, and the Liquidator appointed FitzGibbons and Company, Inc. as Special Deputy Receiver (SDR) for New Century. A copy of the Court’s order is available at New Century’s receivership website (newcenturyliquidation.com).

CANCELLATION OF COVERAGE:

The Court ordered all insurance policies issued by New Century are cancelled effective 11:59 p.m. Central Daylight Time October 3, 2025, except when cancelled prior to that date in the normal course of business (including cancellation at the request of the policyholder), as a result of non-payment of current premium, or upon the normal expiration date.

PREMIUMS:

Until directed otherwise, policyholders should continue to pay premiums as usual in order to continue insurance coverage with New Century until 11:59 p.m. Central Daylight Time on October 3, 2025. Policyholders should consult their broker with any questions regarding the payment of premium. Policyholders should disable automatic payments after their final premium payment.

CLAIMS:

The SDR is gathering claims information to forward to the Texas Property and Casualty Guaranty Association (TPCIGA). There may be a brief delay in adjusting and paying claims. New Century’s receivership website at newcenturyliquidation.com will be updated with information to assist policyholders in filing new claims and inquiring on existing claims.
